- 2013 OLT Seed Grant to ensure conferences sustainable. ACUR Council established
- 2014 Posters in Parliament exhibition and celebration of undergraduate research, with 32 students from 18 universities presenting research in Parliament House, Canberra.
- Undergraduate Research News Australasia (URNA) established

Current Status

- 7 conferences (with this one) at 6 different universities
- 720 Students from 27 Australian and 2 New Zealand Universities presented at ACUR conferences
- 77 Active members of Steering Group from 30 Australian and 4 New Zealand Universities and 14 experts worldwide.
- 13 Issues of Undergraduate Research News Australasia (URNA) published
- 2017 ACUR Incorporated in NSW

7. Membership Fees

- Fees are proposed as follows:
 - Proposed \$3000 for Institution; \$1000 for institutions with less than 3000 students.
 - Affiliate membership: \$500
 - \$75 for those waged specified as full-time employed
 - \$25 unwaged, part-time and retired

- \$10 for students
- These fees do not affect whether students can present at a conference, but Universities will need to be members for their students to be eligible to present at Posters in Parliament.
- The Draft Business Plan suggests particular membership entitlements for each category of membership. The full benefits of membership still need to be defined by the Executive.
- Membership fees for students who present at a conference are included in their conference registration fee. Such fees cover membership for the following year.

- B. Conference Reports
 - i. ACUR 2018 (Neridah Baker, La Trobe University)
 - 66 Registrations, 58 Presentations, 5 submitted full papers
 - Potential publication of papers is being explored
 - Financial report appears that the conference will break even
 - ii. ACUR 2019 (Liz Milward, University of Newcastle)
 - Will be covered in presentation to members following AGM
 - The decision about conference hosting was taken by the Interim Executive, prior to the inaugural AGM following receipt of the Conference Hosting Proposal prepared by The University of Newcastle and in consultation with the Steering Group.

C. General Conference Issues

- Concerns were expressed about having concurrent sessions which require delegates to choose which papers to attend.
- The desirability and practicality of recording sessions through "lecture-capture" processes to provide an ACUR version of "TED-Talks" was discussed. Liz Millward reported that in 2019, it may be possible to do this.
- Conference delegates expressed the desire to contact each other after the
 conference. It was pointed out that this may be resolved with a membership list or
 email list that can be provided to participants and through social media such as
 Facebook.
- A number of questions were raised about publication online of abstracts, papers, and images taken during the conference. The need for students to be made aware of publication of their abstracts or papers was stressed. Clarity about referencing conference presentations in future work was needed to avoid concerns about plagiarism in theses or other publications. The implications regarding

acknowledgement of research funding sources and adherence to ethics agreements if information is put on line were also of concern for some delegates. Students need to have the opportunity to decline to have images in which they appear published online.

• Issues around registration in relation to collecting dietary requirements and accessibility issues for potential participants require attention.

9. Newsletter Report

The Newsletter Coordinator, Eric Pawson reported that:

- Undergraduate Research News Australasia (URNA) appears twice a year in May and November, and includes material sourced from conference presenters and participants
- Sent in hard copy to every vice chancellor in Australia and New Zealand, so that Vice Chancellors become familiar with ACUR
- Paid for by the Assistant Vice Chancellor at the University of Canterbury. The Chair thanked the University of Canterbury for its support of ACUR.
