The financial report has been prepared on an accruals basis and is based on historic costs and does not take into account changing money values or, except where specifically stated, current valuations of non-current assets.

The Association's Committee is responsible for the financial statements and has determined that the accounting policies used and described in Note 1 to the financial statements are appropriate to meet the needs of the members. I have conducted an independent audit of the financial statements in order to express an opinion on them to the members of the Australasian Council for Undergraduate Research Incorporated. No opinion is expressed as to whether the accounting policies used, and described in Note 1, are appropriate to the needs of the members. We disclaim any assumption of responsibility for any reliance on this report or on the financial statements to which it relates to any person other than the members, or for any purpose other than that for which it was prepared.

Our audit has been conducted in accordance with Australian Auditing Standards to provide reasonable assurance as to whether the financial statements are free of material mis-statement. Our procedures included examination, on a test basis, of evidence supporting the amounts and other disclosures in the financial statements and the evaluation of significant accounting estimates. These procedures have been undertaken to form an opinion whether, in all material respects, the financial statements are presented fairly in accordance with Australian accounting standards and other mandatory professional reporting requirements and statutory requirements so as to present a view of the Association which is consistent with our understanding of its financial position and the results of its operations.

LIMITATION OF SCOPE

As in the case of similar organisations, it is impracticable to extend our examination of income beyond that information which is recorded in the books of account. The audit opinion expressed in this report has been formed on the above basis.

Report of the Chair 2022-2023

Introduction

A key question arising from the strategic planning exercise we carried out this year was: how can ACUR add value to universities, academics and students in their efforts to engage students in research? We have been challenged by the changing context of higher education, and we have been mindful that ACUR is not alone and needs to link more substantially with organisations with related agendas.

Adding Value to membership

We have continued to ensure that logos of member universities are visible on our website and we have supported institutional representatives through consultancy visits and face to face meetings, in addition to the myriad of ACUR resources available. The webpage with profiles of individuals engaged in developing undergraduate research experiences is growing and we are now working to reward excellent practice in this space through competitive schemes open to academics and to students to be launched in 2024. Over 1100 students have presented research at ACUR conferences and we are currently working to add value to those experiences through the provision of mentorship opportunities.

Links with other networks

A key rationale for the second ACUR Exchange Colloquium "Creating career-ready graduates: The role of undergraduate research," held In Sydney at Notre Dame University, on 1st February was the idea that new approaches to undergraduate education can come about through cross fertilisation of ideas and networks. Expert speakers talked about employability initiatives, industry-based projects, work-integrated learning and students as partners. Following the Colloquium, edited videos and colloquium resources were made available on the ACUR website. Plans for the student mentorship scheme is one example of how ACUR is following up industry links and partnerships. We are also planning research to follow up a 2010 study investigating industry funding for undergraduate research.

The changing context of higher education

As universities respond to the uncertainties of knowledge production within the Generative AI environment, ACUR has an important role in helping to ensure that all students develop the "researcherly" mindset that comes from sustained engagement in research. In the GenAI context students are already knowledge producers and undergraduate education must increasingly recognise and build on that. As the USA *Council on Undergraduate Research* has recognised, this happens when undergraduate research is viewed as a pedagogical approach to teaching and learning.

Finally

The expanded Executive this year has been important in enabling us to meet a large agenda and to plan for sustained growth. I'd like to extend my thanks to all the members of the ACUR Executive and Student Committees for everything they have done this year to make ACUR such a vibrant and dynamic organisation. I want to thank Donna Bennett for keeping our work on track, and I particularly acknowledge the leadership of François Malherbe in bringing this year's ACUR conference to Swinburne University of Technology.

The Executive Committee has grown this year in line with its increased workload. In view of this, the Executive advises that the following change to the Constitution be put to the AGM.

"There shall be an Executive Committee (hereafter called "the Executive") comprising the Chair, the Vice-Chair, the Treasurer, the serving Conference Organiser, the New Zealand Representative, two Student Representatives, an Executive Officer, and any other roles the Executive may define."

Executive meetings

Four meetings took place by Zoom during the year on 18th November 2022, 21st February, 16th May, and 11th September 2023. In between, there was regular email communication.

Student committee

In the past year, the ACUR Student Committee has concentrated its efforts on two main domains: operational streamlining and programmatic expansion. Under operational streamlining, the committee introduced a Discord server as a centralised communication hub. This server aims to integrate academic and student communities, serving not just as a forum for dialogue but as a collaborative workspace. It has attracted the interest of 12 external academic organisations, thereby amplifying ACUR's outreach and influence. To tackle the administrative bottleneck of password management, especially during committee transitions, a LastPass account has been implemented. This digital vault, controlled by a master key held by the Executive, mitigates the risks associated with password losses and ensures continuity in digital operations.

In terms of programmatic expansion, the committee is in the initial stages of developing a workshop for 2024 in conjunction with the ANU Science Society. This workshop diverges from past events by focusing on the human network within academic research, specifically targeting the mentor-mentee relationship between research supervisors and undergraduate students. It will be held in conjunction with the Three Minute Thesis competition in order to showcase undergraduate research. We also hope to work with similar student-run organisations from other universities. By facilitating these connections, the committee aims to address a latent need in the academic community and pave the way for a more fluid exchange of ideas and opportunities in undergraduate

research. This initiative dovetails with the committee's overarching goal to foster a dynamic and interconnected research ecosystem at the undergraduate level.

Strategic plan

The Executive Committee is required by the Constitution to conduct a review of its activities every two years. The May meeting this year reviewed the Strategic Plan agreed in February 2021. New initiatives within the following four Strategic Projects were agreed:

Strategic Project 1 – Increase Membership

Strategic Project 2 – Gain Sponsorship

Strategic Project 3 – Enhance Profiles and Support Recognition

Strategic Project 4 – Research and evaluation

Progress

Strategic Project 1 – Increase Membership

Increasing Membership continues to be a challenge. This year we have made efforts to bridge the gap between senior decision-makers and people on the ground who are implementing undergraduate research, by contacting and meeting staff of member institutions where possible. Mindful that some institutional members lapsed when COVID struck, we have worked to re-establish membership.

Strategic Project 2 – Gain Sponsorship

We have appointed a Sponsorship officer (Seak Lin Ly) who is now working with the Executive to establish a student career mentorship program that will provide opportunities for companies to mentor students.

Strategic Project 3 – Enhance Profiles and Support Recognition.

We continue to work to develop case studies of good practice and, with this in mind, are now working to establish competitive ACUR medals for demonstrated excellence in initiatives to advance undergraduate research. A Staff and a Student Medal will be available annually starting early in 2024.

Having established profiles of ACUR members on the ACUR website, we are now working to acknowledge significant past contributions to the establishment and development of ACUR.

Strategic Project 4 - Research and evaluation

The ACUR Executive continued to work on research projects to develop understanding of undergraduate research, explore how undergraduate research is being assessed and to evaluate the career effects of ACUR conference presentation.

- 2nd Exchange Colloquium. On 1st February 2023 at the second Exchange Colloquium fortyfive representatives explored how undergraduate research dovetailed with other higher education activities and initiatives.
- ACUR Published two issues of *Undergraduate Research News Australasia* (URNA Issue 22 (Edited by Lilia Mantai), and 23 (Edited by Rachel Spronken-Smith).
- ACUR Established a regular "NewsUpdate" to ensure members are informed of developments on an ongoing basis.

Extract from Section 13 of the ACUR Constitution

13. Executive Committee

- 13.1. There shall be an Executive Committee (hereafter called "the Executive") comprising the Chair, the Vice-Chair, the Treasurer, the serving Conference Organiser, the New Zealand Representative, two Student Representatives and an Executive Officer.
- 13.2. The role of the Executive is to act for ACUR in all matters of policy and practice.
- 13.3. The responsibilities of the Executive are to:
 - a. Implement policy with the advice of the Steering Committee
 - b. Take and implement decisions regarding the ongoing reputation, progress, and work of ACUR,
 - c. Establish, maintain, and publicise criteria and guidelines for institutionswishing to host undergraduate research conference.
 - d. Call for expressions of interest from institutions to host future conferences and make decisions in the light of the criteria for hosting.
 - e. Provide guidance to the chosen conference organising institutions andrevise documentation in the light of their experiences.
 - f. Provide practical help to conference organisers as requested such as documentation, spreadsheets, proformas, publicity etc.
 - g. Monitor conference organisation by representation on conferenceorganising committees.
 - h. Maintain and update mailing lists.
 - i. Assist institutions in gaining sponsorship for future conferences; and
 - j. Design and implement a dissemination strategy.
- 13.4. The Executive has the power to co-opt individuals to address specific issues.
- 13.5. The Executive may nominate one or more individual members and/or institutional nominees or alternates to represent ACUR on joint Working Parties with, or at meetings with, other bodies.
- 13.6. Elected and Co-opted Members of the Executive must be paid-up members of ACUR.
- 13.7. In the interests of good governance, the Executive will complete a biennial self-review and present this at the following Annual General Meeting (AGM).

Report on Undergraduate Research News Australasia (URNA)

Introduction

ACUR's biannual newsletter *Undergraduate Research News Australasia* (URNA) was established in 2010, so it is now in its 13th year. All issues are <u>available on the ACUR website</u>. Since the last AGM, ACUR has published Issues 22 and 23.

Issue 22 featured the ACUR 2022 conference, which took place at the University of Sydney, marking the 10th anniversary of the conference under the theme "Shaping the Conversation". URNA22 published the winning conference presentations in different categories and a diverse range of research stories submitted by undergraduate research students across Australasia.

Issue 23 was edited by Professor Rachel Spronken-Smith from the University of Otago, while Lilia was on sabbatical (Thank You Rachel!), and featured various research studies conducted by talented UG research students across the country, ranging from Qigong to circular economy and political polarisation, and presented reflections on the 2nd ACUR Exchange Colloquium 2023, which took place on the 1st February 2023 at Notre Dame University.

URNA is disseminated to all members and Steering Committee members around the world as well as to all universities in Australia and New Zealand (approximately 1200 individual email contacts).
